'No violation of listing agreement': SEBI gives clean chit to Adani Group in Hindenburg case



New Delhi: Securities and Exchange Board (SEBI) Thursday gave a clean chit to Adani Group in the matter related to the allegations made by US Short seller Hindenburg, concluding that there is no violation of listing agreement or SEBI Listing Obligations and Disclosure Requirements (LODR) and the impugned transactions do not qualify as "related

party transactions". "Reading of Listing Agreement and SEBI Regulations reveals that transactions between a listed company with unrelated party is not covered within the definition of related party transactions as it existed during the time when impugned transactions took place, though included specifically after the 2021 amendment," SEBI said in a statement. The market regulator further highlighted that there is no violation of Section 12A of the SEBI Act and SEBI-Prohibition Fraudulent and Unfair Trade Practices relating to Securities Market Regulations, as alleged. It further concluded that no fraud, misrepresentation, or siphoning of funds was proven and all funds were returned with interest. Thus, all allegations in Show cause Notice not established. SEBI also said that no liability or penalties were imposed on Adani Group entities or individuals

# 'Army Only Place Where There Is No Nepotism': CDS General Anil Chauhan

Ranchi: Chief of Defence Staff General Anil Chauhan on Thursday asserted that the 'Bhartiya fauj' (Indian Defence Forces) is the only place where there is no nepotism, as he urged children to aspire to join the armed forces to serve the nation and explore places. While interacting with school children at an event in Ranchi, CDS General Chauhan said that the armed forces made maximum efforts this year to rescue citizens amid a high number of natural disasters.

"The 'fauj' (army) is the only place where there is no nepotism... You should aspire to join the armed forces



if you want to serve the nation, and explore the country and the world," he said.

While speaking about Operation Sindoor, General Chauhan said that the first strike on the terror camps in Pakistan was conducted at 1 am on May 7 to avoid civilian casualties. "That is the darkest time, it would be the most difficult to get satellite images, photographs, and collect evidence. Yet, we struck at 1 or 1:30 at night. Why was that? It was for two

reasons. First, we had confidence in

our capabilities that even at night we would be able to get imagery. And the second important reason was that we wanted to avoid civilian casualties," he said.

He further said that the best time to strike the terror camps would have been 5:30-6:00 AM, when daylight starts, but at that time, the first Azaan or the first prayer takes place, and in Bahawalpur and Muridke, there might be a lot of movement at that time, so many civilians could have been killed.

Operation Sindoor

Defence Forces launched precision strikes at nine terror camps in

Pakistan and Pakistan-occupied Kashmir (PoK) under "Operation Sindoor" in response to the dastardly Pahalgam terror attack which claimed 26 lives.

In a late-night press statement on May 7, the Indian Defence Ministry said, "A little while ago, the Indian armed forces launched 'Operation Sindoor' hitting terrorist infrastructure in Pakistan and Pakistan-occupied Jammu and Kashmir from where terrorist attacks against India have been planned and directed."

The strikes killed over 100 terrorists, In the early hours of May 7, Indian including 10 family members of Jaish-e-Mohammed (JeM) chief Masood Azhar and four close aides.

## Medico City to be built in Ranchi at a cost of Rs 2,800 crore

strengthen To Ranchi: Jharkhand's healthcare services, the state government has announced the construction of a Medico City in the capital, Ranchi. The Asian Development Bank has approved financial assistance of ?2,800 crore for this ambitious project. The Medico City will be built near Rinpas.

Health Minister Dr. Irfan Ansari called this a historic decision for the state's healthcare system. He said that now the people of Jharkhand will no longer need to travel abroad for treatment of serious illnesses. He added that 12 super-specialty hospitals will be built under the Medico City.

Dr. Ansari said that outside investors are coming to Jharkhand to open hospitals, but they are discouraged by the opposition's politics. I assured them that the state government would provide land electricity, water, and security. Only after I provided these guarantees did the investors agree.

Dr Ansari said that in Medico City, specialist and state-of-the-art treatment facilities for heart, kidney, liver and other serious diseases will be available at one place.



The project will establish a modern Medico-City in Ranchi. It will also include the establishment of a regional medical center, pharmacy, nursing, and paramedical colleges. It will also focus on improving nursing and medical education. developing a digital health system, and modernizing district-level health institutions.

A high-level meeting regarding this project was held under the chairmanship of the Health Minister attended by Additional Chief Secretary Ajay Kumar Singh, Executive Director Dr. Neha Arora, and ADB representative Sonalini Khetrapal. It was decided that the tender process would be initiated soon to expedite the work.

Additional Chief Secretary Ajay

Kumar Singh said that this initiative by the Jharkhand government will not only improve the quality of health services but will also provide a new direction to the social and economic development of the state. Projects like Medico City will ensure that every citizen has access to better and accessible health facilities within their own

The project will cost ?2,800 crore (approximately \$2.8 billion), including ADB funding. It will develop green building technology and telemedicine-based infrastructure. The project will be implemented through a public-private partnership model and will contribute to the Sustainable Development Goals.

While there is a shortage of doctors

in the state, Jharkhand still fares better than the national average in terms of infant mortality and maternal mortality rates. However, we lag behind in institutional deliveries, which need to be improved. The role of social welfare officers, health medical officers, and Anganwadi workers and ASHAs in all districts is crucial during Nutrition Month. They will all

work together for 15 days. During this period, 4,000 camps will be set up every day across Jharkhand. Include vegetables and fruits of all colors in your plate. Nutrition Month will focus on which foods to reduce to stay healthy and what to include in a healthy diet. He advised reducing your intake of foods like sugar, refined flour, and oil. Reducing these amounts on your plate will be important for your health. Include vegetables and fruits of all colors on your plate. # Khajuraho Temple idol plea after social media outrage

New Delhi, Agency: Chief Justice of India (CJI) Bhushan R Gavai on Wednesday said that he respects all religions, suggesting he did not intend to hurt the religious sentiments of any community while dismissing a petition earlier this week that sought the restoration of a seven-foot beheaded idol of Lord Vishnu at the Javari temple, part of the Khajuraho group of monuments in Madhya Pradesh.

"Someone told me the other day that the comments I made have been portrayed in social media in a certain manner...I respect all religions," the CJI said.

Solicitor general Tushar Mehta and senior counsel Kapil Sibal, who were present in the court for a matter, underlined the danger social media presents. "This is serious. We used to know Newton's third law that every action has an opposite and equal reaction. But now, every action has a disproportionate social media reaction," Mehta said. Sibal added, "We suffer every day. This is an unruly horse, and there appears to be no way to tame it."

The CJI's statement came in the wake of criticism on social media over his reported comments on Tuesday, which many alleged were offensive to the Hindu community and its deity. "The petition was not entertained because there were strong legal grounds to do so. There was absolutely no intention to cause hurt to anyone's faith or religious beliefs," the CJI said.

The controversy was amplified after Delhi-based advocate Vineet Jindal sent a letter to the CJI on Tuesday, urging him to withdraw his remarks. Jindal wrote that the had left the idol unrepaired.



observations offended the religious sensibilities of Hindus, adding that they were being widely discussed across platforms.

On Tuesday, a bench of CJI Gavai and Justice K Vinod Chandran declined to entertain a plea filed by one Rakesh Dalal, who sought directions to restore the idol. The bench held that the issue fell within the jurisdiction of the Archaeological Survey of India (ASI) and not the court.

The CJI had remarked to the petitioner: "Go and ask the deity itself to do something now. You say vou are a staunch devotee of Lord Vishnu. So go and pray now. It's an archaeological site, and ASI needs to give permission, etc. Sorry."

The petition, argued by senior advocate Sanjay M Nuli, claimed that the idol was mutilated during Mughal invasions and remained damaged despite repeated representations to the government to restore it. It cited the history of the Khajuraho temples, built by the Chandravanshi kings. The plea alleged that both colonial neglect post-independence inaction

## CJI clarifies remarks on Uttarakhand to file review plea in SC against acquittal in 2014 rape, murder case

New Delhi, Agency: [Uttarakhand] will not be Uttarakhand chief minister Pushkar Singh Dhami on Thursday said the state government will file a Supreme Court against the acquittal of an accused in the 2014 rape and murder of a seven-year-old girl. He said the government remains committed to ensuring justice.

"The justice department has been directed to file a review petition in the case and ensure a conviction," he said. Dhami added the government would deploy its best legal team. "Those who commit such heinous Devbhoomi

spared. The government stands firmly with the victim's family.'

Dhami said the adminreview petition in the istration is conducting verification drives across the state to identify and keep a check on anti-social elements.

The nine-year-old girl's body was recovered five days after she went missing November Nainital's Kathgodam, triggering outrage. In March 2016, a special court sentenced Akhtar Ali to death and co-accused Prem Pal to five years' rigorous imprisonment. The Uttarakhand high court upheld Ali's



death sentence in 2019.

On September 10, the Supreme Court set aside the conviction and acquitted Ali. A bench of justices Vikram Nath, Sanjay Karol, and Sandeep Mehta rejected the DNA analysis cited as proof against Ali. It noted a botany expert lacking expertise in human DNA profiling conducted

The Supreme Court warned trial courts against the mechanical application capital punishment without ensuring the highest standards of proof and procedural fairness. It said this undermines the rule of law and risks the gravest miscarriage of justice by extinguishing a human life irretrievably.

Hundreds of people took to the streets on Sunday and submitted a memorandum asking the state government to challenge the verdict. The girl's uncle threatened selfimmolation if a review plea was not filed.

Finally, US President Trump's lies were exposed. The Foreign Minister of Pakistan, a US stooge, exposed President Trump by revealing that India had not accepted third-party mediation regarding the ceasefire. During an interview with Al Jazeera, Pakistan's Deputy Prime Minister and Foreign Minister, Muhammad Ishaq Dar, said, "When the ceasefire proposal came from Rubio (US Secretary of State) on May 10th, I was told that talks between India and Pakistan would take place at a neutral venue. But when I met Rubio in venue. But when I met Rubio in Washington on July 25th, I asked what happened to the talks. He said, 'India considers it a bilateral matter.'" This interview clearly demonstrates that the US President had no role in the ceasefire between India and Pakistan. It also became clear that India neither accepts nor has the policy of accepting third-party mediation in bilateral matters. Indeed, from May 10th until recently, President Trump has consistently claimed that his efforts led to a ceasefire. Both countries acted wisely and intelligently, averting a potential nuclear war. India has consistently denied this boasting. These claims were also rejected within Parliament. This may be the underlying reason why there was no communication between President Trump and Prime Minister Modi for 90 days. This silence broke after June 17th, when Trump called Prime Minister Modi to wish him a happy birthday and also said that he was doing a great job.

Prime Minister Modi shared what he said in response: "My friend, President Trump, thank you for your phone call and warm wishes on my birthday. Like you, I too am committed to taking the India-US comprehensive and global partnership to new heights." However, the lies were exposed, but the conversation between the two world leaders has cleared the way for the relationship. Trade agreement talks had stalled after the US's 50% tariff on India. However, on Tuesday, September 16th, Representative Brendan Lynch was in New Delhi. He held talks with Rajesh Aggarwal, Special Representative of the Union Ministry of Commerce, for nearly seven hours. Both described the talks as

'positive.'

# Idol worship is the life force of India!

To understand the soul of India, one must understand idol worship. It is not just a religious ritual; it is a spiritual tradition dating back millennia, one that has given this country the courage to stand firm in every crisis.

Hinduism has always recognized that the human mind cannot contemplate the formless. It needs symbols, embodied forms, in which it can focus its devotion and faith. This is why idols have never been merely stone or metal objects; they have always become living symbols after consecration.

When a Hindu devotee stands before an idol, he sees in it not an inanimate rock, but the embodiment of his faith. The mere sight stabilizes his mind, energizes him, and refines his soul. This is why temples have never been merely religious sites; they are living centers of Indian society and culture. When invaders destroyed temples and severed the heads of idols, they knew they were hurting the soul of India. India rose from the ashes every time thereafter. because its life force resided in these idols and temples. The of Islam and Christianity, despite their best efforts, failed to destroy Hindus, while many countries have experienced the destruction of their original culture. Among these countries, there are many whose current generations do not even know where their roots lie! Yet, amidst all this, India stands unbroken and eternal.

Against this backdrop, the Supreme Court's recent comment deeply pained every Hindu. The seven-foot-tall

statue of Lord Vishnu at the Javari Temple in Khajuraho, Madhya Pradesh, was vandalized centuries ago during Mughal invasions. Devotee Rakesh Dalal filed a petition demanding its restoration. He argued that this was not merely an archaeological issue, but a question concerning the devotees' right to worship. Now, what was wrong in saying this? When the ASI can restore broken idols in many temples across the country to their original state by scientifically treating them with the powdered stone of the idol, why can't this experiment be done here? But the Supreme Court, dismissing the petition, said, "If you are such a staunch devotee of Lord Vishnu, then go and pray to him."

This comment is merely a sentence; its real implications are profound. It gives rise to a narrative in which approaching Vishnu means either abandoning one's physical body or becoming completely silent in devotion to Hari in the light of the soul. In either case, one is no longer able to express one's concerns to the court or any-

one else. In a way, these words appear to mock the faith of millions of Hindus.

For example, "If your gods are so true, why couldn't you save yourself?" It's not that these voices have disappeared: these voices have disappeared; social media is filled with these statements and similar expressions, suggesting that there is a segment of the country that

continues to challenge Hindu idol worship. But today, when this same voice was heard in the judiciary's language, it has dealt a further blow to Hindu

The question arises: if this comment had been made about any other religion, sect, or faith, would the reaction have been so calm? In reality, this inequality and injustice are the biggest problems facing Hindus today, which, despite being the majority, are being tortured in the name of secularism. When minorities feel insulted, they take to the streets, resorting to sloganeering and violence. Even the courts have often been seen to tolerate their aggression in the name of sensitivity and reli-gious rights. Even if public posters of the accused are posted, the court takes suo motu cognizance, expresses its displeasure, and orders their immediate removal. On the contrary, Hindus seek solutions to their problems in the Constitution and the courts. But what is this? They too are receiving ridicule and contempt from the courts! This sends a very dangerous message that the path of violence yields results, and the path of restraint leads to neglect. It

must be said that this poses a serious challenge to Indian democracy and social balance. The courts' responsibility is not merely to interpret the law; they must also respect the beliefs of citizens. If the

Supreme Court had felt that this case fell within the jurisdiction of the Archaeological Survey of India, it could have simply declared, "We will not hear it, the matter pertains to the Archaeological Survey of India." But how appropriate is it to say, "If you are such a staunch devotee of Lord Vishnu, then go and pray to

It's also important for the judges sitting in court to understand that if a Hindu worships idols, they aren't superstitious. It's part of their spiritual journey. Idols allow them to see the formless in the concrete. They become the center of their meditation, practice, and devotion. This is why devotees stand in line for hours in temples, just to catch a glimpse of their deity (God). Upon seeing them, they feel their lives have been blessed. It's this faith, psychology, and cultural strength that has sus-tained India despite repeated ruptures.

Îdol worship is the soul of Indian civilization. Dismissing it as superstition or ridiculing it in court is not only an insult to millions of devotees but also an insult to the cultural heritage that has kept India united. The broken statues of Khajuraho are not just statues, but a reminder of the wounds of our civilization. Their restoration is not merely an archaeological task, but a demand for justice.

Persons with disabilities should participate in decision-making processes, from local bodies to the national level. No policy or plan can be complete without listening to their needs and suggestions.

Society's role is even greater. one is left behind.

Every individual should ensure that persons with disabilities live with dignity and equality in their homes, neighborhoods, and workplaces. Their participation in public events, election rallies, and cultural events should increase. This is possible only if we treat them with rights, not pity. The

Indian Constitution guarantees equality, dignity, and freedom. If a large segment of society remains deprived of these rights, democracy remains incomplete. ### US may ease tariffs on India in next couple of months, CEA V. Anantha Nageswaran says

New Delhi, Agency: India's chief economic adviser is confident that the US will ease punitive tariffs on India in the next couple of months to levels which "we were earlier anticipating".

"My personal confidence is that in the next couple of months-if not earlier-we will see a resolution to at least to the extra penal tariff of 25%," CEA V. Anantha Nageswaran said during an event organised by the Bharat Chamber of Commerce in Kolkata on Thursday. "It may also be the case that the reciprocal tariff of 25% may also come down to levels, which we were earlier anticipating, somewhere between 10% and 15%.'

On 27 August 2025, the United States imposed an additional 25% tariff on India, doubling the over-



all levy to 50%, due to Russian oil imports, which Washington says is fuelling Moscow's war in Ukraine. That pushed India closer to US rivals China and Russia, as was visible during the SCO Summit late last month.

There have been some signs of thaw since then.

At least two teams of US officials are in India to hammer out an India-US trade deal, which was put on ice following US President Donald Trump's tariff tantrum.

### Fifty Days to go for centenary: Hockey India one of the favourites in Asia Cup India prepares to celebrate the greatest Afghanistan head coach Jonathan Trott milestone in India's sporting history

New Delhi, Agency: Calling for Pan-India celebrations to mark the centenary of Indian hockey - a journey which began in 1925 when the first national sports body was formed, Hockey India has launched the 50-day countdown which will culminate in special celebrations November 7 this year.

While the actual details of the celebrations will be revealed in due course, Hockey India delved into the sport's incredible history underlined by the eight Olympic Gold medals - maximum won by any country in the sport till date and also the maximum number of medals in any discipline won by India at the Olympics, as per a press release from Hockey India.

Speaking about the significance of hockey contribution that outlined the country's immense potential on a global stage even before Independence, Gurbux Singh, the oldest living legend of the sport who has won Olympic Gold for India in the 1964 Tokyo Olympics, expressed, "The first hockey tournament held in India was the Beighton Cup in 1895. The National.

Hockey Association was formed in 1925, and India won the Olympic Gold in 1928, just three years after the body was established. From then on, India won gold in 1932, 1936 and if the Games was held in 1940 and 1944 if not for WWII, we would have won two more gold medals. It was the Dhyanchand era, and we



totally dominated the world."

Gurbux also pointed out that Britain did not field a hockey team until 1948 for the fear of, 'losing to India'. "Hockey not only contributed to India's sporting history but also to nationalism. The team's performance was important to bring in a sense of oneness as a nation. The British fielded a hockey team only in 1948 because they feared losing to India when they ruled us. And to beat them in their own backyard after we won Independence was one of the greatest moments in Indian history," Gurbux explained.

The legend also recollected how Ali Dara was flown in for the final in the Berlin Olympics to strengthen the squad. "Germany (a club side with most of their national team players) had beaten India in practice matches. When we were pitted against them in the final, Dara was flown in for that match. One must also understand, back then the federation didn't have the money.

Yadav is a fantastic player, obviously, as he's captain now. So it's an extra added "I think Suryakumar responsibility, so I look forward to seeing how he goes with that leadership role," he added.

Afghanistan all-rounder Gulbadin Naib heaped praise on Team India, calling them the best side in Asia as well as the world. Having shared the dressing room with Indian players in the Indian Premier League (IPL), Naib said he has always enjoyed learning from them.

"India is the best team in Asia and in the world, you get to learn a lot from these boys," Naib told agency.

# Neeraj Chopra, Arshad Nadeem crash out of World Athletics Championships final

New Delhi, Agency: finish a creditable fourth. India versus Pakistan rivalry post Pahalgam failed to kick off at the World Athletics Championships in Tokyo as both the reigning Olympic Champion Arshad Nadeem defending World Champion Neeraj Chopra were eliminated from the javelin final on Thursday.

Nadeem registered two foul throws in his quota of four, registering a best throw of 82.75 metres to finish tenth in the final.

Neeraj finished eighth after registering a foul throw in the penultimate round of the final. His best throw of 84.03 metres came in his second attempt.

Chopra was outperformed by debutant compatriot Sachin Yadav who logged a personal best performance to

Yadav's best throw of 86.27m, which came in the very first attempt, was a personal best performance and he bested not just Chopra but also German star Julian Weber (86.11m), and Nadeem among others.

The gold went to Keshorn Walcott (88.16m) of Trinidad followed Tobago, Grenada's Anderson Peters Curtis (87.38m)and Thompson (86.67m).

The tournament rules stipulate that the 12-man field starts to thin from the third round where the last two in the rankings get eliminated after every attempt.

The fans were looking forward as to how Chopra and Nadeem would behave on the track and field, coming days after the handshake contro-



versy where the Indian cricket team refused a customary handshake with the Pakistan team after their convincing seven-wicket win last Sunday.

after he pipped Neeraj for the gold medal at last year's Paris Olympics.

"We are very happy with the silver, the one who got gold is also our child and the one who got silver is also our child. All are athletes, all work hard. Nadeem is also good, he plays well. There is no difference between Neeraj and Nadeem. We got gold and silver, there is no difference for us," she had told the reporters after the javelin final.

A year later Neeraj was heavily criticised for extending the invitation to Arshad in the aftermath of Pahalgam attack for the inaugural Neeraj.
